

**ORDER**

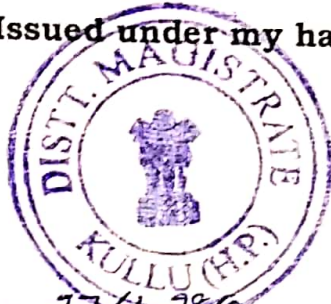
In continuation to this office order No. 1318-6-/MA dated 24-03-2020, subsequent order dated 03-05-2020 and partial modification of office order no. 2223-2320/MA, dated 26-04-2020, it is hereby further ordered that:

1. The curfew relaxation hours shall be now w.e.f. **09:00 AM to 04:00 PM** daily.
2. All the permissible activities as specified in earlier orders, shall only be permitted during curfew relaxation hours as mentioned above. It is once again reiterated that the movement of general public for accessing services of shops shall be allowed during permissible timing of 9:00 AM to 4:00 PM subject to the condition that: (i) only one person of a family shall go out for this purpose and movement shall strictly be from house/place of stay to the point of delivery of essential items/service and back; (ii) all such movement shall be on foot nearest shop/store/bank branch and no vehicle shall be allowed; (iii) every person moving out shall use mask/face cover. The norms of social distancing and sanitation shall be strictly followed by all concerned. No vehicles shall be allowed in market area except medical emergency/goods vehicles/vehicles carrying officials on duty and all vehicles must park outside market. Only 3 persons shall be allowed in a four-wheeler and no pillion will be allowed on two wheeler.
3. The intra-district(within district) movement of individuals shall be allowed without curfew pass during curfew relaxation hours only subject to the conditions mentioned in forgoing para.
4. All inter-district and inter-state movement of individuals is strictly prohibited except on the basis of curfew pass issued by the competent authority.


