**ORDER (further relaxation in Curfew during the COVID-19
lockdown).**

Whereas, the Ministry of Home Affairs, Government of India has issued detailed directions for mitigating hardship to the general public during the national lockdown period from 15-04-2020 to 03-05-2020, vide letters No.40-3/2020-DM-1(A) dated 15-04-2020 and 16-04-2020.

Whereas the Additional Chief Secretary (Health) has stipulated certain mandatory conditions for the lockdown in the State of HP vide order no. HFW-A-A(3)1/2020 dated 14-04-2020 .

Whereas, the Chief Secretary to the Government of Himachal Pradesh has directed all Departments and District Magistrates to ensure strict implementation of the MHA Guidelines with certain specific modifications vide order no. Rev. (DMC) (C) 20-2/2020-COVID-19 dated 18-04-2020.

Whereas, Govt. of India, Ministry of Home Affairs, vide its order No. 40-3/2020-DM-I(A) dated 24th April, 2020, has further given relaxation under Clause 14, Sub-clause (xiii) & (xiv) on Commercial and private establishments.


Whereas, Govt. of Himachal Pradesh has taken decision to relax curfew hours in the morning to allow morning walk. Further the State Govt. has allowed to increase the relaxation of curfew hours for four hours instead of three in the day time (apart from morning).

Therefore, in exercise of powers conferred under section 144 of the Criminal Procedure Code, 1973 and in addition to the earlier order No. 1742-1806/PA dated 20th April, 2020, I Kamal Kant Saroch, District Magistrate, Lahaul & Spiti, do hereby order that with effect from 27th April, 2020, the following activities shall also be permissible in District Lahaul & Spiti.



1. All shops registered under the Shops and Establishment Act of the respective State/UT, including shops in residential complexes and market complexes, except shops in multi-brand and single brand malls, outside the limits of municipal corporations and municipalities, with 50% strength of workers with wearing of masks and social distancing being mandatory shall remain open during the relaxation in curfew hours.
2. In order to ensure health and immunity of the general population, morning walk is permissible from 5:30 AM to 7:00AM (this shall be permitted w.e.f. morning of 26th April, 2020).
3. All the shops mentioned in Para 1 (a) and para 1 (b) of earlier order No. 1742-1806/PA dated 20th April, 2020, and these mentioned against Sr. No. 1 of this order shall remain open from 10:00AM to 2:00PM from 27th April 2020. The curfew shall remain relaxed during 10:00AM to 2:00PM from 27th April for the general public.
4. The relaxation related to opening of all the shops shall not be available to Barber shops. The Barber shops shall remain closed till further orders.
